

## **Consent to the processing of personal data**

I, in accordance with Article 9 of Federal Law No. 152-FZ of 27.07.2006 "On Personal Data", give specific, substantive, informed, conscious and unambiguous consent to the processing of my personal data by Interizgroup Limited Liability Company (LLC

- fulfillment of obligations stipulated by the legislation of the Russian Federation;
- settlement of disputes that have arisen between me and the Operator, both judicial and non-judicial, including the transfer of personal data to third parties for the purpose of providing legal services to the Operator;
- performing advertising activities with consent, including providing information about new training products.
- providing technical support for the use of the Site.

The Operator may process personal data by:

collection, recording, systematization, accumulation, storage, refinement (updating, modification), use, transfer (provision, access), depersonalization, blocking, deletion, destruction.

I consent to the transfer of data to third parties: Yandex. Metrica, payment operators, and other third parties, if this is necessary for the purposes indicated above.

Consent is provided by me consciously and voluntarily for the period until the purposes of processing personal data (specified in this consent) are achieved, with the possibility of unilateral revocation at any time.

It was explained to me that in the event of revocation of this Consent to the processing of personal data, the Operator has the right to continue processing personal data without my consent, if there are grounds specified in paragraphs 2-11 of Part 1 of Article 6, Part 2 of Article 10 and Part 2 of Article 11 of the Federal Law of 27.07.2006

No. 152-FZ (Part 2 of Article 9 of the Decree. the law).

Other personal data is subject to destruction or depersonalization within 30 days from the date of receipt of the written revocation of this Consent.

The term of validity of this Consent begins from the moment it is submitted to the Operator and ends upon achievement of the purposes of personal data processing, upon receipt of revocation of consent to the processing of personal data or exclusion of the Operator from the Unified State Register.
